ADP Funding Eligibility for Respiratory Devices

Please see below the Assistive Devices Program (ADP) criteria for the funding of your CPAP/APAP/BIPAP device.

225 Positive Airway Pressure Systems

225.1 Items included in a Positive Airway Pressure System

A positive airway pressure device, heated humidifier, a basic mask and headgear (or an upgraded mask and headgear), a carrying case, 6 ft tubing, all necessary caps/filters, and a user instruction manual.

The upgraded mask and headgear are not included in the funding amount provided for a positive airway pressure system.

505 Requests for a Replacement Device

505.01 Clients who have received ADP-funded respiratory Devices and continue to meet the general (see the ADP Manual, Policy 300, Eligibility Criteria for Program Benefits) and Medical Eligibility Criteria (see Part 3, Applicant Eligibility Criteria for Respiratory Equipment), are eligible to re-apply for funding either during or after the designated minimum funding period has expired, if there is:

- a documented change in the Client's medical/respiratory status and the ADP-funded respiratory Device no longer meets the Client's basic respiratory needs, as defined by the ADP; or
- damage due to normal use and wear, and the Client confirms that the respiratory Device is no longer under warranty and the cost of the repair is more than one third of the original purchase price.

Treatment Cost

The Assistive Devices Program (ADP) in Ontario states that ALL vendors MUST supply a patient with:

- A CPAP machine with humidifier, a hose, and a standard mask for \$554.00

ADP pays 75% of the cost or \$415.50 directly to the vendor you purchase your CPAP machine from. You pay \$138.50. **ADP will provide funding for a new machine once.**

NOTE: If you require a specialty mask, i.e., nasal pillows or a full-face mask, there may be an additional fee. Vendors may also be charging an initial registration and setup fee.

Many Insurance Companies cover the cost of your machine portion and the cost of future supplies. Contact your insurance company to learn more.
